INTRODUCTION

Globally, optimism is rising for international travel, and all the data coming out of the Internet, ranging from Google to online tour operators and online data research firms confirms this. But it would be wrong to suggest that the tourism sector is getting back to normal. There's still some way to go, and without doubt 2021 will be characterised by domestic trips.

However, there's a rapidly growing number of destinations that are open to travellers with two vaccinations, as long as they take a test before travelling and complete an online travel declaration form. Despite the extra hassle and cost, many people are happy enough to do this if it means they can travel again – not least as many have vouchers from cancelled trips and lots of company holiday time to use up. In this issue we've taken a look at the current tourism status of the UK's overseas territories as an interesting cross-section of islands and how they are preparing for tourism to restart.

We've also included a round-up of the latest travel trends based on consumer internet research and booking patterns, which also show that things are improving with regards to international travel, even if long haul trips are probably more likely in 2022 than 2021.

HOW ARE OTHER OVERSEAS TERRITORIES OPENING UP?

The opening of destinations to tourism is a topic that is extremely current for both travellers wanting to get back on the road, and for destinations wanting to get their economies back on track. At the moment it's a mixed bag, ranging from destinations opening up for those with two jabs through those that still remain closed to everyone except returning residents. Without doubt, leisure tourism will remain highly restricted as long as quarantine remains in place for travellers on arrival at a destination (at least for more than 48 hours).

We've researched the current entry conditions for all of the UK's overseas territories to get a feel for what the other islands are doing. Overall there is considerable variation. The good news for British travellers is that all OT's are currently on the Green List, meaning that no quarantine is required when returning back home after a trip. But what about on arrival? The table provides more complete details, but in summary they can be divided into three groups:

- **Open for tourism**: Bermuda, British Virgin Islands, Gibraltar, Turks and Caicos Islands
- **Open but with quarantine between 5-10 days**: Anguilla, Cayman Islands, Montserrat, Saint Helena/Ascension/Tristan da Cunha
- Closed: Pitcairn Islands

What is becoming increasingly common is the requirement to complete an online travel authorisation form. These are usually quick and easy (and from the perspective of Tourist Boards/Governments are brilliant for data and knowing more about visitors). The other trend is the opening up of the Caribbean. Increasing numbers of countries are now opening



up to vaccinated travellers without requiring quarantine; it is expected that Montserrat and Cayman Islands will join these shortly.

Note: Where a traveller is vaccinated, proof is always required in the form of a Vaccination Certificate.



Even with COVID-19 vaccine distribution ramping up, many travellers are continuing to take trips closer to home, and choosing car travel as their preferred mode of transportation. At least for now (most probably for the remainder of 2021), road trips will continue to eclipse air travel and other transportation methods. And finally...

Health and hygiene remains important...

Domestic travel will remain strong...

Since the start of the pandemic, health and hygiene related factors have grown in importance for travellers. Analysis of guest review data shows a steep spike in consumers mentioning cleanliness in their reviews. Since March 2020 over one third of all guest reviews of accommodation properties mention cleanliness, further highlighting the importance put on cleaning. It is estimated that 4 in 5 travellers make accommodation decisions based on measures implemented following the pandemic.

Making up for lost time with longer trips...

To make up for lost time, travellers are finally using their full vacation days and taking advantage of more flexible working conditions with "flexications" – a longer stay mixing work and play. This is resulting in longer trips as well as more long-haul travel. Several destinations are now offering "Digital Nomad" visas that allow travellers to stay in a country for up to one year for "flexications". Looking at destinations in the LATAM region, interest is currently highest for travel to Mexico, with Cancun, Playa del Carmen and Mexico City topping the list of destinations being searched for and booked. But...

LATEST TRAVEL MARKET TRENDS

More than a year after COVID-19 shutdowns and restrictions started impacting countries around the world, the travel industry is definitely on the road to recovery, which, just like sporting events, is starting to learn how to live with the virus.

All indicators show that travel optimism is on the rise and Internet searches for travel (as reported by Google, Expedia and most other online travel agents) are rapidly rising. Some of the key trends spotted by Expedia are shown below.

Short lead time on planning trips...

Continuing the trend seen throughout much of last year, the majority of bookings are made 0-21 days before a trip is taken, as uncertainty around global travel saw travellers opt for more opportunistic, short-term trips closer to home. However, this is largely driven by the surge in domestic travel. For international travel, 30% of bookings are made 3 months or more before travel
